OFEA Required Release of Information for approved OFEA Shows:

“Liability Clause State Law and our insurance company have advised us to use the following Liability Statement on all show flyers:

Participation Agreement, Notice Release, and Acknowledgement of Risk:

I accept and clearly understand that riding a horse can be hazardous, especially in an equestrian event; that there are inherent and other risks involved in riding a horse; and that injuries are a common and ordinary occurrence. I freely accept and assume those risks. I therefore release Oregon Family Equestrian Activities, Inc. (OFEA), its members and show grounds’ owners and all of their agents and employees, from any and all liability for damage and injury to myself, my horse, or to any person or property resulting from my riding a horse in this equestrian event, accepting myself the full responsibility for any and all such damage or injury of any kind which may result. I agree to fully indemnify, defend, and hold OFEA, show grounds’ owners and all of their agents and employees, harmless from any and all claims, actions, liability, or costs including attorney fees and other costs of defense, arising out of or in any way related to my riding a horse in this equestrian event. The limitations on liability provided in ORS 30.691 shall apply to an adult participant in the circumstances listed in subsection (1)(b) of this section if the participant, prior to riding, training, driving, grooming or riding as a passenger upon an equine, knowingly executes a release stating that as a condition of participation, the participant waives the right to bring an action against the equine professional or equine activity sponsor for an injury or death arising out of riding, training, driving, grooming or riding as a passenger upon the equine. A release so executed shall be binding upon the adult participant. I hereby certify that every horse is eligible as entered. I make these entries at my own risk and understand that equine events are potentially dangerous. Show management, owners of the facility, and/or Oregon Family Equestrian Activities shall not be held responsible for any accident, injury or loss that may occur to any exhibitor, their representatives, or to their horses, equipment, or vehicles. Presentation of this entry with my entry fee shall be deemed acceptance of the above. I understand and agree that this show shall be conducted under the rules of Oregon Family Equestrian Activities and that of the Show Management In applying for OFEA show approval, the undersigned and sponsoring organization agrees to that the show will follow the rules Oregon Families Equestrian Activities, Inc. and that of Show Management.”

Show Liability Release

I assume all risks and damages from losses under this show whether or not caused in whole or in part by Pacific Equestrian Club, Inc., Green Acres, Oregon Families Equestrian Activities (OFEA) and their collective officers, directors, employees, agents, representatives, affiliates, agents and/or assignees and insurers (collectively hereafter PEC/Green Acres/OFEA).

In consideration of the PEC/Green Acres/Oregon Family Equestrian Activities allowing my participation in this show (Equitation), I, (on behalf of myself or minor child), my heirs, administrators, personal representatives, assignees, and children, spouses, if any, do hereby agree to hold harmless, release and discharge Pacific Equestrian Club, Inc., Oregon Family Equestrian Activities, Green Acres Horse Facility, which includes collective owners, officers, directors, representatives, affiliates, agents, and/or assignees and insurers, of and from all claims, demands, causes of actions and legal liability whether known or unknown, anticipated or unanticipated from my use under this show at the Green Acres Facility, arenas, and ancillary facilities, from my use whether in whole or in part caused by PEC/Green Acres/OFEA. I shall not bring any claims, demands, legal actions or causes of actions against PEC/Green Acres/OFEA for any damage or loss due to bodily injury, death, property, equipment, trailers or vehicles damage rising out of my participation in this horse show.

Presentation of this show entry agreement and signature below shall be deemed acceptance of show rules, terms and conditions of participation, provides a waiver in accordance with ORS.30.687-693. In addition, under ORS 105.682, the fees associated with this show only apply to the outdoor/indoor arenas and associated parking facilities at the Green Acres facility. I am and am aware that any other uses of property, or any use of the property outside the identified fee area are not subject to a charge and therefore, PEC/Green Acres/OFEA is also not liable for injuries, death, or property damage arising out of such uses of the property for which no specific charge has been made. Show management reserves the right to cancel or reschedule any show without notice.
